Charter will remain the same between the towns. There is a contract between the towns and some members of the board will talk with our lawyers this Friday to go over said contract.

Whereas, the adoption of this 2024 budget for the Byron Bergen Public Library requires a tax levy increase that exceeds the tax cap imposed by the state law as outlined in General Municipal Law Section 3-c adopted in 2011; and

Whereas, General Municipal Law Section 3-c expressly permits the library board to override the tax levy limit by a resolution approved by a vote of sixty percent of qualified board members; now therefore be it

Resolved, that the Board of Trustees of the Byron Bergen Public Library voted and approved to exceed the tax levy limit for 2024 by at least the sixty percent of the board of trustees as required by state law on December 6, 2023.
